This strategy combines both discretionary and rules-based approaches, allowing flexibility in response to changing market conditions. The Fund invests in a diversified range of eligible global assets including but not limited to equities (and equity-related securities), fixed income/debt securities, currencies and cash and its equivalents. Exposure to the asset classes will be primarily (at least 66% of the Sub-Fund's net assets) through: direct equity and fixed income/debt securities (including sovereign debts, high yield securities, CMBS, ABS, MBS and convertible bonds), units of undertakings for collective investment, exchange traded funds, money market instruments and financial derivative instruments ("FDIs") (such as forwards, futures, options, swaps, swaptions, credit default swaps and total return swaps).
